# **Letter From The CEO**

Dear Members,

Despite initial concerns regarding membership numbers, our strategic budget approach allowed us to maintain essential member services while preparing for a slight decline in Primary and Secondary Memberships. We successfully welcomed numerous members from surrounding associations, with a remarkable 94% renewal rate among transfers from 2022.

We continued our commitment to member engagement and community service through initiatives like the "REALTORS® Do More," campaign and supporting NAR REALTOR® Safety Month. Our efforts also led to a significant increase in RAF Major Donors, achieving over 50, marking a 25% growth from last year.

Our Government Affairs team had notable success, particularly in defeating the Community Opportunity to Purchase Act (COPA) and organizing a successful Legislative Day at the capital. Additionally, we hosted our first-ever Real Awards event, celebrating top producers and raising funds for Down Payment Assistance grants.

SCCAOR expanded professional development opportunities by hosting a record number of agents for NAR Designations and offering new pricing models to enhance participation in classes. Our DEI initiatives thrived, including a Fair Housing event featuring esteemed speakers and our inaugural Down Payment Assistance Fair, which attracted over 100 attendees.

Our Foundation distributed \$70,000 in grants to assist first-time home buyers and engaged in numerous community support activities, all made possible through generous member contributions.

As we conclude 2023, our strategic planning, led by C.A.R. CEO John Sebree, positions us well for future growth. Through innovative teamwork and adaptability, SCCAOR continues to thrive in the evolving real estate landscape.








**TOTAL TRANSACTIONS IN 2023**

## **ADVOCATING FOR OUR MEMBERS**

SCCAOR Advocacy champions REALTOR® Party values on behalf of our members. We achieve this by advocating for our members' business rights, private property rights, homeownership, and increasing housing supply and affordability. The REALTOR® Party speaks with one voice to advance candidates and public policies that build strong communities and promote a vibrant business environment.

Our Advocacy team consists of our professional government affairs team that receives direction from our Local Government Relations Committee and Local Candidate Recommendation Committee. Our passionate SCCAOR members respond to our Call for Actions, vote for REALTOR® Party champions, and support our grassroots initiatives to ignite positive change.

### **2023 ADVOCACY HIGHLIGHTS**

- SCCAOR was heavily engaged in the San Jose City Council's discussion about the Community Opportunity to Purchase Act (COPA), which was a burdensome and unnecessary proposal that would have interfered with the ability to sell property - hundreds of SCCAOR members participated in several committee meetings that led to the Council opposing COPA with a 9-2 vote
- SCCAOR members spoke before the San Jose City Council in support of Mayor Matt Mahan and his effort to secure Emergency Interim Housing (EIH) funds to get homeless on the streets and in our creeks into shelters
- SCCAOR educated the city councils of several cities about the significant costs inherent in electrification mandates
- Hosted a REALTOR(R) Action Fund (RAF) Major Donor appreciation luncheon at the Capital Club to honor those who contributed to RAF at the highest level

### **PROFESSIONAL STANDARDS**



SCCAOR's Dispute Resolution Committee volunteers and staff are some of C.A.R.'s most recognized and respected representatives.

In 2023, the Grievance Committee reviewed 13 ethics complaints. One complaint was converted to a citation. One complaint was dismissed by the Grievance Committee.

There were 11 Professional Standards Disciplinary Hearings and three Arbitration hearings. There were two Director Reviews of the disciplinary hearing panel's decision.

One Mediation request was filed and withdrawn.

Christine Borg, Professional Standards Coordinator, represented SCCAOR as a panel member for a C.A.R. discussion of best practices to all Professional Standards Coordinators statewide.




